Following the reported transaction above, Mark and Robyn Jones, together with their trusts, continue to own beneficially 1,462,691 shares of Class A Common Stock and 14,107,841 shares of Class B Common Stock, for a total of 15,570,532 shares of Goosehead Insurance, Inc.
